 - a. Cherry Creek and Duvall Projects ADAP project contractor selection: requests for bids were announced in three newspapers, to the SVWID email list, personal communications to potential bidders known to SVWID staff, and emailed to MRSC roster for the Cherry Valley and Duvall ADAP projects. Site visit took place June 17. Two contractors submitted bids. Pacific Sitework's bid was considered incomplete and not responsible. IO Environmental and Infrastructure's bid was the only remaining complete and responsible bid for both packets. IO Environmental's bid was within staff's estimated budget. Motion was made seconded, and approved 3:0 to authorize Cynthia to enter into a contract with IO Environmental and Infrastructure, Inc. for the Cherry Valley drainage projects in the amount \$106,943 for the tasks in the bid packet.
