

The Snoqualmie Valley Watershed Improvement District (SVWID) extends this invitation to bid on the “Remlinger Farms Culvert Replacement Project - 2022” to all qualified bidders. Sealed bids (range \$350,000 - \$400,000) must be mailed to the Snoqualmie Valley Watershed Improvement District at P.O. Box 1148 Carnation, WA 98014 and must be received by Wednesday, May 4, 2022. The SVWID will not accept hand-delivered or virtually submitted bids. A Virtual Public Bid Opening will be held at approximately 2:00 P.M. on Wednesday, May 4, 2022 on Zoom: <https://us02web.zoom.us/j/8795810071?pwd=cHNhNWlFQTFuZFF4aWtOQytCZz09> (Meeting ID: 879 581 0071, Passcode: SVWID). Within 72 hours following the public bid opening, bids will be available for public review on the SVWID website: [www.svwid.com](http://www.svwid.com). Sealed Bids received after the specified “received by” date will not be accepted. All Bid Items will be Lump Sum or Incidental to other Bid Items. All bidders will be required to attend the on-site pre-bid meeting at 10:00 A.M. on Tuesday, April 26.

Major bid items will include Structure Excavation Class A; Receival, Offload, Movement, and Installation of two (2) Precast Concrete Box Culverts (heaviest pick weight approximately 40,000 lbs.); Utility Work; Temporary Stream Diversion and Groundwater Dewatering; Instream Large Wood Habitat Structure Installation; and other items in conformance with the 2020 WSDOT Standard Specifications, the Engineering Plans, and Specifications. Knowledge and experience with water pumps, bypass setup, and dewatering wells is critical. Knowledge of and respect for aquatic animal species removal and relocation is highly sought due to the high numbers of coho salmon and other species of fish in Langlois Creek. All aquatic animals will be removed by SVWID staff.
